### **ENGAGE-IL REGISTRATION**

The ENGAGEIL.com website is the portal to enroll and complete the OALIG education modules. Learners will create a password-protected account, which includes completion of a learner demographic profile. Learners will have access to their account by using their username and password.

### **TARGET AUDIENCE**

This ENGAGE-IL activity has been planned by and for an interprofessional audience of healthcare professionals interested in geriatrics.

### **COMPLETION REQUIREMENTS**

In order to earn continuing education credit the learner must:

1. Watch the video associated with the module.
2. Complete the CE assessment questions embedded in the video-based module.
3. Complete the course evaluation survey.

### **ASSESSMENT OF LEARNING OUTCOMES**

Learning objectives have been created for each module. Learning objectives are assessed by questions embedded in the online video. Learners are prompted to answer assessment questions after the pertinent content has been presented during the video. Upon responding to an assessment question, the learner will be notified by the online system whether to reflect on the question and re-answer (in the case of an incorrect answer) or to move forward in the case of a correct response.
